Article 2.132(b) CCP Law Enforcement Policy on Racial Profiling. The Callahan County Sheriff's Office has adopted a detailed written policy on racial profiling. Our policy

- (1) Clearly defines acts constituting racial profiling;
- (2) Strictly prohibit peace officers employed by the CALLAHAN COUNTY SHERIFF'S OFFICE from engaging in racial profiling;
- (3) (3) implements a process by which an individual may file a complaint with the CALLAHAN COUNTY SHERIFF'S OFFICE if the individual believes that a peace officer employed by the CALLAHAN COUNTY SHERIFF'S OFFICE has engaged in racial profiling with respect to the individual;
- (4) (4) provides public education relating to the agency's complaint process.
- (5) (5) requires appropriate corrective action to be taken against a peace officer employed by the CALLAHAN COUNTY SHERIFF'S OFFICE who, after an investigation, is shown to have engaged in racial profiling in violation of the CALLAHAN COUNTY SHERIFF'S OFFICE'S policy adopted under this article;
- (6) Require collection of information relating to motor vehicle stops, in which a citation is issued and to arrest made as a result of those stops, including information relating to:
 - (A) the race or ethnicity of the individual detained;
 - (B) whether a search was conducted and, if so, whether the individual detained consented to the search; and
 - (C) whether the peace officer knew the race or ethnicity of the individual detained before detaining that individual; and
- (7) requires the chief administrator of the agency, regardless of whether the administrator is elected, employed or appointed, to submit an annual report of the information collected under subdivision (6) to :
 - (A) the commission on Law Enforcement Officer Standards and Education: and

(B) the governing body of each county or municipality served by the agency, if the agency is an agency of a county, municipality, or other political subdivision of the state.
