Certification to this report 2.132 (Tier 1) – Partial Exemption

Article 2.132(b) CCP Law Enforcement Policy on Racial Profiling
COMBES POLICE DEPARTMENT has adopted a detailed written policy on racial profiling. This policy:

1. Clearly defines acts that constitute racial profiling;
2. Strictly prohibits peace officers employed by the Combes Police Department from engaging in racial profiling;
3. Implements a process by which an individual may file a complaint with the Combes Police Department if the individual believes that a peace officer employed with the Combes Police Department has engaged in racial profiling;
4. Provides public education relating to the agency's complaint process;
5. Requires appropriate corrective action to be taken against a peace officer employed by the Combes Police Department who, after an investigation, is shown to have engaged in racial profiling in violation of the policy adopted under this article;
6. Require collection of information relating to motor vehicle stops in which a citation is issued and/or arrests made as a result of those stops, including information relating to:
 - (A) The race or ethnicity of the individual detained;
 - (B) Whether a search was conducted and, if so, whether the individual detained consented to the search; and
 - (C) Whether the peace officer knew the race or ethnicity of the individual detained before detaining that individual; and

7. Require the chief administrator of the agency, regardless of whether the administrator is elected, employed, or appointed, to submit an annual report of the information collected under Subdivision 6 to:
 - (A) The Commission on Law Enforcement Officer Standards and Education;
and
 - (B) The governing body of each county or municipality served by the agency, if the agency is an agency of a county, municipality, or other political subdivision of the state.
