## **2011 Racial Profiling Report – Tier 1**

Since January 1, 2002, the Harris County Sheriff's Office, in accordance with the Texas Racial Profiling Law (CCP Art 2.132), has been collecting law enforcement contact data for the purpose of identifying and responding as necessary to concerns regarding racial profiling practices. In compliance with changes made by House Bill 3389, our agency further submits the required data contained herein to TCLEOSE.

Our agency claims partial racial profiling report exemption because our vehicles that conduct motor vehicle stops are equipped with digital video and audio equipment and we maintain videos for 90 days.

**Certification to This Report 2.132 (Tier 1)** – Partial Exemption: Article 2.132(b) CCP Law Enforcement Policy on Racial Profiling.

The Harris County Sheriff's Office has adopted a detailed written policy on racial profiling which:

- (1) clearly defines acts constituting racial profiling;
- (2) strictly prohibits peace officers employed by the Harris County Sheriff's Office from engaging in racial profiling;
- (3) implements a process by which an individual may file a complaint with our Office if the individual believes that a peace officer employed by our Office has engaged in racial profiling with respect to the individual;
- (4) provides public education relating to the agency's complaint process;
- (5) requires appropriate corrective action to be taken against a peace officer employed by the Harris County Sheriff's Office who, after an investigation, is shown to have engaged in racial profiling in violation of the Harris County Sheriff's Office's policy adopted under this article;
- (6) requires collection of information relating to motor vehicle stops in which a citation is issued and to arrests made as a result of those stops, including information relating to:
  - (A) the race or ethnicity of the individual detained;
  - (B) whether a search was conducted and, if so, whether the individual detained consented to the search; and
  - (C) whether the peace officer knew the race or ethnicity of the individual detained before detaining that individual; and
- (7) requires the chief administrator of the agency, regardless of whether the administrator is elected, employed, or appointed, to submit an annual report of the information collected under Subdivision (6) to:
  - (A) the Texas Commission on Law Enforcement Officer Standards and Education; and
  - (B) the governing body of each county or municipality served by the agency, if the agency is an agency of a county, municipality, or other political sub-division of the state.
