Article 2.132(b) CCP Law Enforcement Policy on Racial Profiling

La Salle County Constable Pct 4 had adopted a detailed written policy on racial profiling. Our policy:

- (1) Clearly defines acts constituting racial profiling;
- (2) Strictly prohibits peace officers employed by the La Salle Co Constable pct 4, from engaging in racial profiling;
- (3) Implements a process by which an individual may file a complaint with the La Salle Co Constable Pct 4, if the individual believes that a peace officer employed by the La Salle Co Constable Pct 4 has engaged in racial profiling with respect to the individual;
- (4) Provides public education relating to the agency's complaint process;
- (5) Requires appropriate corrective action to be taken against a peace officer employed by the La Salle Co Const Pct 4 who, after an investigation, is shown to have engaged in racial profiling in violation of the La Salle Co Const Pct 4's policy adopted under this article;
- (6) Require collection of information relating to motor vehicle stops in which a citation is issued and to arrest made as a result of those stops, including information relating to:
  - (A) The race or ethnicity of the individual detained;
  - (B) Whither a search was conducted and, if so, whither the individual detained consented to the search; and

- (C) Whether the peace officer knew the race or ethnicity of the individual detained before detaining the individual; and
- (7) Require the chief administrator of the agency, regardless of whether the administrator is elected, or appointed, to submit an annual report of the information collected under Subdivision (6) to :
  - (A) The Commission on Law Enforcement Officer Standards and Education; and
  - (B) The governing body of each county or municipality served by the agency, of the agency is an agency of the county, municipality, or other political subdivision of the state.
